WHEREAS extremely dry conditions exist within Cartwright-Roblin Municipality;
AND WHEREAS By Law #8-2015 authorizes council to initiate a burning ban when the risks are high;
BE IT RESOLVED THAT a ban on all outdoor burning EXCEPT PERMITTED AND MONITORED FIRE PITS FOR COOKING WITH WATER SUPPLY NEARBY in Cartwright-Roblin Municipality is hereby activated until further notice.

Procedure for Burning Bans

1. Fire Chief recommends burning ban

2. Council resolution puts burning ban on
3. Prep burning ban notice/ advertisement including who is impacted, effective dates, type of burn ban (eg: absolutely no fires including fire pits, outdoor fireplaces etc. OR WITH EXCEPTION OF PERMITTED + MONITORED FIRE PITS WITH WATER SUPPLY NEARBY)
4. Send notices to:
 - o Office of the Fire Commissioner (OFC) and copy Fire Chief: firecomm@gov.mb.ca **immediately** when implementing or changing the status of municipal burning restrictions because this information gets put onto an interactive map showing all current municipal burning restrictions: www.gov.mb.ca/wildfire/burn_conditions.html
